

SUBJECT: DECLARATION OF INTEREST

NSW legislation provides strict guidelines for the disclosure of pecuniary and nonpecuniary Conflicts of Interest and Political Donations.

Council's Code of Conduct also deals with pecuniary and non-pecuniary conflict of interest and Political Donations and how to manage these issues (Clauses 7.5 - 7.27).

Councillors should be familiar with the disclosure provisions contained in the Local Government Act 1993, Environmental Planning and Assessment Act, 1979 and the Council's Code of Conduct.

This report provides an opportunity for Councillors to disclose any interest that they may have or Political Donation they may have received relating to a Report contained in the Council Business Paper and to declare the nature of that interest.

RECOMMENDED

SUBJECT: PUBLIC ADDRESSES

The Public Address segment (incorporating Public Question Time) in the Council Meeting provides an opportunity for people to speak publicly on any item on Council's Business Paper agenda or on any matter within the Local Government area which falls within Council jurisdiction.

Speakers must book in with the Council office by 4.00pm on the day of the meeting and must advise the topic being raised. Only seven (7) speakers can be heard at any meeting. A limitation of one (1) speaker for and one (1) speaker against on each item is in place. Additional speakers, either for or against, will be identified as 'tentative speakers' and should only be considered where the total number of speakers does not exceed seven (7) at any given meeting.

Where a member of the public raises a question during the Public Address segment, a response will be provided where Councillors or staff have the necessary information at hand; if not a reply will be provided at a later time. There is a limit of one (1) question per speaker per meeting.

All speakers are limited to 4 minutes, with a 1 minute warning given to speakers prior to the 4 minute time period elapsing.

Public Addresses are recorded for administrative purposes. It should be noted that speakers at Council meetings do not enjoy any protection from parliamentary-style privilege. Therefore they are subject to the risk of defamation action if they make comments about individuals. In the event that a speaker makes potentially offensive or defamatory remarks about any person, the Mayor/Chairperson will ask them to refrain from such comments.

The Mayor/Chairperson has the discretion to withdraw the privilege to speak where a speaker continues to make inappropriate or offensive comments about another person.

SUBJECT: LOCAL DEVELOPMENT PERFORMANCE MONITORING REPORT 2010-2011

FROM:Director, Development and HealthBINDER:Development & Building Controls/Statistics

PURPOSE OF REPORT

To inform Council that the 2010/2011 Local Development Performance Monitoring Report has been released, and to provide a snapshot of the data published relevant to Camden. The full report is available on the Department of Planning and Infrastructure's website at <u>www.planning.nsw.gov.au</u>

BACKGROUND

On 18 February 2012, the Department of Planning and Infrastructure released the Local Development Performance Monitoring report for 2010-2011.

The report provides comprehensive statistics about development in NSW, including annual information on the volume, value and type of development and Council processing times. The report is compiled by the Department and based on the Department's analysis of data supplied by local Councils.

MAIN REPORT

In 2010/2011, Council determined 1,582 DA's and approved \$348.7 million worth of development within Camden. The mean DA determination time with 'stop the clock' was 31 days and the median DA determination time with 'stop the clock' was 20 days.

Compared with 2009/2010, the number of DA's determined increased by 9% and the value of development approved in Camden declined by 16%.

Of the DA's determined in Camden, 43% were for single dwellings. In 2010/2011, Council approved 685 new single dwellings, compared with 1,078 in Blacktown, 92 in Campbelltown, 639 in Liverpool and 292 in Penrith.

In 2010/2011, Council's mean gross determination time was 32 days for single dwellings, 47 days for alterations and additions and 64 days for commercial, retail and offices DA's.

Mean gross determination time means the average time taken by Council to determine a DA when time is measured from the day the application is lodged to the day the application is determined and no days are excluded.

During 2010/2011, Council issued 130 subdivision certificates. This compares with 163 in Blacktown, 21 in Campbelltown, 79 in Liverpool and 53 in Penrith.

SUBJECT:SUPPORT FOR CYSTIC FIBROSIS SWIMATHONFROM:General ManagerBINDER:Ward Funds

PURPOSE OF REPORT

This report seeks Councillors' endorsement for the allocation of funds totalling \$770 to support the Cystic Fibrosis, (CF) Swimathon held recently. Inclement weather required an additional marguee to be hired for the event launch.

BACKGROUND

The annual event raises funds for CF NSW and is a well supported community event.

MAIN REPORT

The annual Swimathon for Cystic Fibrosis was held on Saturday 11 February 2012.

Many swimmers took part in the event which raised more than \$73,000 for CF NSW. The event was a fun day for participants and their supporters, with swimmers of all abilities and ages taking part in the free event. There were swimmers in the flippers and floaties lane and some very fit athletes swam hundreds of laps in the endurance lanes.

For the third year running a Swim Launch event was held at Camden Valley Inn with a major auction and Hennings Diamond Draw on Thursday, 9 February at 6pm. Due to the inclement weather organisers required an additional marquee to be hired at a cost of \$770.

Council has made a donation of \$500 to the event under its Donations policy but as this was additional and unexpected expenditure, it is requested that this additional cost of \$770 be met by Council (for example, via Councillors Ward Funds which currently has an uncommitted balance of \$6,720).

CONCLUSION

Councillors' support is sought for this contribution to help cover additional, unexpected costs for this event.

SUBJECT:CAMDEN SHOW 2012FROM:Director GovernanceBINDER:Camden Show

PURPOSE OF REPORT

The purpose of this report is to seek Council's determination of a request from the Camden Show Society for additional sponsorship of the 2012 Camden Show.

BACKGROUND

The Camden Show started in 1886 and is one of the largest events in Camden and seeks to promote agriculture through competitions and education within the Macarthur region.

Since its inception, the event has continued to grow with over 38,000 visitors at last year's event, which was officially opened by Her Excellency Ms Quentin Bryce AC, Governor General of the Commonwealth of Australia.

This year's event is again expected to attract large crowds as the Inaugural Camden Show Farmer of the Year Awards are launched by Australian Farmer of the Year Ambassador, Glenn McGrath.

MAIN REPORT

The Camden Show Society has requested Council give consideration to providing additional financial support again in 2012 for this year's Camden Show by providing \$3,000 to assist with the distribution of 35,000 event programs in the Macarthur area.

A potential source of funding for this request is Councillors Ward Funds which currently has an uncommitted balance of \$6,720 (subject to ORD02).

This year the event will commence Thursday evening 22 March and conclude Saturday 24 March with the event being officially opened by Australian Farmer of the Year Ambassador, Glenn McGrath.

This year Council has already committed significant expenditure (a combination of \$660 in cash and in-kind support) towards the event.

CONCLUSION

Council considers the Camden Show a worthwhile community event and the additional \$3,000 funding provided by Council will help increase the event's profile within the local and wider community.

It should be noted that no money has been allocated in the 2011/12 budget for this additional sponsorship.
