#### MOTION

- 13.2 to read "...by completing the "Councillor Travel and/or Expense Claim" Form (Appendix A) and attaching the relevant receipts".
- 21.1 (d) to be made 21.2 and read "If points 21.1 (a), (b) and (c) have been satisfied, reimburse the reasonable legal expenses;
  - (a) only if the enquiry, investigation, hearing or proceedings taken against a Councillor results in a finding substantially favourable to the Councillor."
- 25.2 to read "...the Mayor may request the use of a Council pool vehicle, or, if a Council pool vehicle is unavailable, a hire vehicle, similar to the current Council fleet vehicles, for official Council business, if a vehicle is required."

  - Upper South Creek Floodplain Risk Management Study and Plan,
  - Nepean River Flood Study and Floodplain Risk Management Study and Plan Review, and
  - Narellan Creek Flood Study Review and Climate Change Impact Analysis; and
- iii. formally write to the Office Environment and Heritage thanking them for the contribution towards these projects.
