  - (c) that the application fee for operators to obtain a revised approval under the new scheme be waived for those who hold a valid current approval for outdoor dining as at the date of the Council's adoption of the policy and who apply for a revised approval by 5 December 2014;
- ii. that the application fee for outdoor dining remain unchanged at \$230.00 (GST free) per annum;
- iii. that following the public exhibition process a report be brought back to Council for adoption; and
- iv. that page 2 of the Application Form be amended to read under point 2, bullet point two, "location of all doorways and service openings".
