CC01 ACQUISITION OF LAND FOR ROAD PURPOSES - WESTBROOK ROAD, BICKLEY VALE

Resolution: Moved Councillor C Cagney, Seconded Councillor Morrison that Council:

- i. resolve to acquire land at Westbrook Road, Bickley Vale (as shown on the attached plan) by agreement with the landowner for the purpose of improving access and visibility of the intersection in accordance with the requirements of the *Land Acquisition (Just Terms Compensation) Act 1991*;
- ii. approve the agreement between Council and the landowner for the acquisition of the land for the agreed amount of \$1,000;
- iii. make an application to the Minister and the Governor for approval to acquire the subject land at Westbrook Road, Bickley Vale by agreement under section 177(1) of the *Roads Act 1993*; and
- iv. authorise the General Manager, or his nominee, to execute the application for the acquisition by agreement of the land and to finalise and execute associated documents including payment of all reasonable survey, valuation and legal fees incurred by the owner.
