- i. write to the Minister for Planning, the Premier and Cabinet members, as well as the Department of Planning, and advise that we do not support this proposal in its current form and that the people of Camden deserve a much better planning outcome for this very significant portion of land in our LGA; the precinct falls dramatically short of meeting the expectations of our current and future communities expectations with regards to residential amenity regarding density and lot size; appropriate usable open space; the lack of infrastructure; the lack of realistic employment opportunities; the lack of appropriate commercial controls; and that there is no current guarantee of reasonable heritage protection for the site;
- ii. endorse the draft submission to the draft Lowes Creek Maryland Precinct Planning package and resolve to forward this submission to the Department of Planning and Environment;
- iii. endorse the draft letter relating to Council's concerns on contributions planning and resolve to forward this letter to the Minister for Planning;
