We, the undersigned Councillors, hereby give notice of our intention to move that the following Council resolution relating to Item ORD 01 of Ordinary Council Meeting of 14 April 2009, Minute No. ORD76/09 – “Proposed Construction of a Local Area Command Centre for the New South Wales Police Force at Lot 2 DP 882155, 278 Camden Valley Way, Narellan” **BE RESCINDED.**  
(Extract of Minute No ORD 76/09) (File1300.795)

*That:*

- i. support the State Environmental Planning Policy 1 objection to the development standard which limits buildings to two storeys;*
- ii. use the delegation provisions of SEPP 1 and grant consent to the construction of a Local Area Command Centre at Lot 2, DP 882155, No. 278 Camden Valley Way, Narellan;*
- iii. seek the concurrence of the NSW Police Force to the imposition of the draft conditions of consent attached to this report pursuant to the provisions of Section 116C of the Environmental Planning & Assessment Act, 1979, as amended;*
- iv. afford delegation to the Director, Development & Environment to issue development consent for the construction of a Local Area Command Centre upon receipt of the concurrence to the draft conditions of consent provided the agreed conditions reflect the intent of this report.*

***In the event that the above Motion of Rescission be carried, it is our intention to move the following further Motion:***

That Council defer consideration of this report pending an appeal to the Minister for the Application to be refused for the following reasons:

- Overdevelopment of site;

- Scale, bulk and height of proposed building;
- The development is not appropriate for the site;
- The development is not sympathetic to the heritage zone;
- Inadequate transition of height to the heritage buildings;
- Inadequate provision for on site car parking;
- The scale and setback in reference to view corridors resulting in view lines being breached;
- Inadequate vehicular access to the site and safety concerns;
- The inappropriate location in relation to the adjacent established residential areas and adverse impacts of Noise;
- Volume of traffic is unacceptably high;
- Economic reasons – cost of police resources used due to the site not being in proximity to a Court House.
