## **Terms and Conditions for all Stall Holders**

### **General:**

1. Sites will be allocated by the Visitor Centre. Stall sizes are 6 metres x 3 metres.
2. Stall fees will be \$50 for commercial stands and \$75 for food stalls, non refundable and free for community and not for profit groups.
3. All stall holders must hold current public liability insurance cover. Please provide a copy of this attached to your application form. It is the responsibility of all stallholders to arrange public liability insurance to cover any claim arising out of their activities as stallholders.
4. Applications and stall fees must be received **no later than Friday 2 September 2011.**
5. No monies will be collected on the day, all payments to be made prior to the event.
6. All cheques and money orders to be made payable to the **Camden Visitor Centre.**

### **Food Items:**

Food must comply with the guidelines for food stall holders. Information regarding the guide can be obtained by contacting Camden Council's Environment & Health Branch on 4654 7777. Health Inspectors have the authority to close down any stallholder who does not comply with the Health Regulations. NO refunds will be given.

### **Power:**

Stallholders are responsible for supplying sufficient power to their site. No electrical leads are to be placed on the ground.

### **On the day**

1. Hours of operation are from 10am to 2pm.
2. Entry to stall area will be via the Curry Reserve Carpark from 8.30am.
3. **All Stallholders are to drop off their equipment and goods at their site number and move ALL vehicles to the Parking Area. ALL VEHICLES MUST BE REMOVED BY 9.30AM** unless their vehicle is part of their stall.
4. All participants agree to abide by the instructions and directions of the members of the Visitor Centre, Festival Committee, SES and designated volunteers.
