LTC01 Business Arising From The Committee's Last Report

SYNOPSIS

The Local Traffic Committee report dated 2 August 2022 was presented to Council meeting on 11 October 2022. Council adopted the Local Traffic Committee's recommendations apart from LTC06.

Agenda item LTC06 of the Local Traffic Committee Meeting held 2 August 2022 be the subject of a future Councillor briefing, which is to include details on:

- a. what triggered the issue, including whether it was a request by one or more residents;
- b. how the excess speed was determined; and
- c. what was the scope of Council's consultation and research into the matter.

LTC02 Central Avenue, Oran Park - Centre Line-Marking And Zebra Crossing Signage

SYNOPSIS

Concerns have been raised regarding driver behaviour along Central Avenue, Oran Park. Line-marking is proposed to help address the issue.

TRAFFIC COMMITTEE DISCUSSION

Council's Traffic Engineer gave an overview of item.

The Committee members agreed with the Council Officer's recommendations.

OFFICER'S RECOMMENDATION

The Local Traffic Committee recommends that Council approves in Central Avenue, Oran Park, between Peter Brock Drive and Dick Johnson Drive:

- Replacement of existing separation (S1) line-marking with double barrier (BB) linemarking; and
- ii. Pedestrian Crossing Ahead (W6-2) warning signs.

TRAFFIC COMMITTEE RECOMMENDATION

LTC03 Healy Avenue, Gregory Hills - No Stopping Restrictions At The Intersection With Discovery Circuit

SYNOPSIS

Concerns have been raised regarding vehicles parking too close to the intersection of Healy Avenue with Discovery Circuit, compromising sightlines. No Stopping restrictions are proposed to address this.

TRAFFIC COMMITTEE DISCUSSION

Council's Senior Traffic Engineer gave an overview of item.



The Committee members agreed with the Council Officer's recommendations.

OFFICER'S RECOMMENDATION

The Local Traffic Committee recommends that Council approves in Healy Avenue, Gregory Hills, at the intersection with Discovery Circuit:

- i. 17 metres of No Stopping (R5-400 signage) on both sides of Healy Avenue;
- ii. 10 metres of No Stopping (R5-400 signage) on Discovery Circuit; and
- iii. 10 metres of double barrier (BB) centre lines on Discovery Circuit.

TRAFFIC COMMITTEE RECOMMENDATION

LTC04 Turner Road, Currans Hill - Centre Line-Marking Between Ascot Drive And Spring Hill Circle

SYNOPSIS

Concerns have been raised regarding traffic flow issues caused when vehicles are parked along the eastern side of the road between Bridle Road and Hilltop Avenue.

TRAFFIC COMMITTEE DISCUSSION

Council's Traffic Engineer gave an overview of item.

Council's Team Leader Ranger Services advised that have received a number of complaints from local residents regarding the vehicles parked on eastern side and support measures to help address this.

The Committee members agreed with the Council Officer's recommendations.

Concerns have been raised regarding motorists not having clear sightlines to identify the location of the zebra crossing outside at the neighbourhood centre at Harrington Park and speeding on Fairwater Drive between Camden Valley Way and Correllis Street. Line-marking is proposed to address these concerns.

TRAFFIC COMMITTEE DISCUSSION

Council's Team Leader Traffic and Road Safety gave an overview of item.

The Committee members agreed with the Council Officer's recommendations.

LTC08 Berkshire Circuit, Leppington - Reconfiguration Of Intersection With Beulah Street At Homeworld Display Village

SYNOPSIS

Concerns have been raised by Council's Waste Management Service about access for waste vehicles near HomeWorld display home village in Leppington. Amendments at an intersection are proposed to address the issue.

TRAFFIC COMMITTEE DISCUSSION

Council's Team Leader Traffic and Road Safety gave an overview of item.

Council's Waste Technical Officer and WHS Advisor supported the recommended traffic measures.

Council's Manager Traffic Depot and Building Services advised Council will continue to monitor the matter and advise committee of any further recommendations.

- Mitchell Street between Elizabeth Street and Edward Street.

 - i. the event classified as Class 2, under the Transport for NSW Guide to Traffic and Transport Management for Special Events, Version 3.5, July 1, 2018;
 - ii. traffic management arrangements shall be implemented in accordance with the approved Special Event Transport Management Plan and associated certified Traffic Guidance Schemes;



- iii. the event is controlled by NSW Police with support from Council through TfNSW accredited traffic controllers;
- iv. the organisers providing proof of a minimum \$20 million Public Liability Insurance Policy;
- v. the organisers shall obtain NSW Police concurrence to the Special Event approval;
- vi. the organisers shall maintain access for emergency vehicles along the sections of closed road at all times:
- vii. temporary signage associated with the Traffic Guidance Schemes shall be installed and removed at the end of the event:
- viii. the event being advertised on on-street signage a minimum of seven days prior to the event:
- xi. businesses along the closed road sections and local bus companies being advised of the traffic management arrangements in writing, by the organisers; and
- x. access is facilitated for vehicles turning from Cawdor Road into the service station on the corner of Cawdor Road and Barsden Street.

<u>Larkin Street, Camden – Streets as Shared Spaces Pilot Project</u>

Council's Team Leader Traffic and Road Safety reported the recent Streets as Shared Spaces Pilot Project which has now has concluded. This incorporated the trial of one way traffic movement from John Street to Larkin Place. Council is minded to revert back to two way traffic movement further to community feedback and will be progressing this with Transport for NSW. Other traffic measures in Larkin Place are proposed to be retained.

New Traffic Delegations to Council

Council's Team Leader Traffic and Road Safety advised that the NSW Government has introduced a Traffic Management and Pedestrian Works Delegation which will give Councils the option of carrying out some works on local roads with requiring referral to the Local Traffic Committee or Transport for NSW.

Council officers are currently working through internal processes and will advise the committee as and when processes may change.

NSW State Electoral Boundary Changes

Council's Team Leader Traffic and Road Safety reported there are some boundary changes for the upcoming NSW election cycle. Different parts of Camden Local Government area will fall within the boundaries of the Camden, Leppington and Badgerys Creek electoral districts. This will mean three State MPs will be voting members on the Camden Local Traffic Committee for proposals within their electoral districts.
