Key Points:

- 3m Section (150m²) of BEP Circus paddock proposed to be acquired.
- Acquired section to be fenced with white arris rail fencing
- Council to be requested to maintain monument garden once established
- Ref. Grp. members expressed concern that this may set a precedent for more land acquisitions from the BEP for non equestrian purposes.

Motion: That the BEP Reference Group supports in principal the construction of an Emergency Services memorial, however, recommends that the project does not include the acquisition of ground from the Circus Paddock or adjoining land within the BEP.
