# **Busking in Camden LGA**



Approved sites available for busking activity:

1. National Australia Bank corner, 125 Argyle St, Camden. Cnr of John and Argyle St.



This busking location is outside the heritage Federation building of the National Australia Bank in the main business precinct of Argyle St Camden. The building hosts several local businesses and the nearby area is a popular pedestrian thoroughfare surrounded by retail shops, eating places and cafes. It is also nearby Camden's cultural precinct, including Alan Baker Art Gallery, Camden Library and Camden Museum. This site is suitable for solo or small group (maximum of three performers).



2. Royal Hotel Camden corner, 39 Argyle St, Camden. Cnr of Elizabeth and Argyle St.

This busking location is outside the Royal Hotel Camden on the main street of Camden. The hotel has a variety of dining options and functions throughout the day and night to late. The precinct is surrounded by local businesses and dining places. This site is suitable for solo or duo group.

3. Camden Civic Centre, Cnr of Mitchell and Oxley St, Camden. Front grass area facing Oxley St.



The location is outside the cultural hub of the Camden Civic Centre which hosts a variety of community, events from celebrations, weddings, special events, school formals, and private and corporate events during the day and night. It is the main venue for performing arts in Camden and presents a range of live performances by local groups and touring shows with national and international artists. It is opposite Woolworths in Oxley St and around the corner from Camden Pool. This site is suitable for solo or duo group.



4. Alan Baker Art Gallery, 37 John St, Camden. Outdoor courtyard.

Alan Baker Art Gallery at the historic Victorian building, Macaria, is close to the business precinct of Argyle St. The Gallery showcases a collection of Australian artist Alan Baker's artworks and is an active creative hub for local artists, residents, tourists, schools, children and their families. The Gallery has an extensive public program of exhibition tours, workshops, and special events. The Gallery is part of Camden's cultural precinct, being opposite the Camden Library and Camden Museum and nearby Camden Civic Centre. This site is suitable for solo or small group performances (maximum of three performers).

5. Narellan Library, Cnr of Queen & Elyard St, in the plaza forecourt.



This busking location is outside Narellan Library on Elyard St facing Narellan Town Centre. It has the opportunity to attract lunchtimers, shoppers and passersby. The Library has a range of programs and activities throughout the day which attract children, families, and young people. This site is for solo or small group performances (maximum of five performers). No amplified music.

6. Oran Park Library, 72 Central Ave, Oran Park. Front forecourt.



This location, situated opposite Perich Park and next to Camden Council's Administration Building, has the opportunity to local residents, lunchtimers, passersby, visitors to the Library and Council, and Council staff during the day. The Library has a range of programs during the daytime which attract children and families. Council holds a number of community events throughout the year in Perich Park. This site is suitable for solo or small groups performances (maximum of five performers). No amplified music.

7. Camden Library, 40 John St, Camden. Outside front of library (restricted hours).



Closeby the main business precinct on Argyle St, the Library houses a multifunction room for community groups and events, an exhibition space, the Camden Museum and the Camden Area Family History Society. Visitors of all ages attend the venue for a range of activities. It is situated opposite the Alan Baker Art Gallery, nearby a school and close to a bus stop. It has frequent pedestrian activity, though is busiest on weekday afternoons when school finishes. Busking activity is permitted outside in the forecourt. This site is suitable for solo or duo performers.



8. Blooms Chemist, 146-148 Argyle St, Camden. Outside shopfront on footpath.

Outside Blooms Chemist in the main business precinct of Argyle St Camden, this location has frequent pedestrian activity as it is surrounded by retail shops, local businesses, cafes, restaurants and gift stores. This site is suitable for solo or duo performers. Signs cannot be posted on the shopfront windows and there cannot be any obstruction to shoppers entering the store. Suitable for both daytime and nightime busking.

- 9. 118 Argyle St, Camden. Cnr of John St on footpath.

The location is on the corner of John and Argyle St and is situated in the main business precinct of Argyle St, Camden. It has frequent pedestrian activity, surrounded by retail shops, local businesses, cafes, restaurants and gift stores. Busking activity is permitted outside the shopfront on the footpath. This site is suitable for solo or duo performers. Signs cannot be posted on the shopfront window or and there cannot be any obstruction to shoppers entering the store. Suitable for both daytime and nightime busking.



10. Sarita's A Collective Emporium, 154 Argyle St, Camden. Outside shopfront on footpath.

The location is outside Sarita's A Collective Emporium in the main business precinct on Argyle St Camden. It has frequent pedestrian activity, surrounded by retail shops, local businesses, cafes, restaurants and gift stores. Busking activity is permitted outside the shopfront. This site is suitable for solo or duo performers. Signs cannot be posted on the shopfront windows and there cannot be any obstruction to shoppers entering the store. Suitable for both daytime and nightime busking.

Bookings at this site are at the discretion of Sarita's A Collective Emporium. Buskers must first contact Sarita's A Collective Emporium on 4655 5555, prior to booking the site with Camden Council.

11. Julia Reserve Community Centre, Peter Brock Dr, Oran Park. Underneath shelter overlooking skate park.



This busking site at Julia Reserve Community Centre is located amongst a number of attractions for young people. Sitting at the centrepiece of Julia Reserve is an integrated multi-dimensional skate park with skateable elements featured throughout the park. The reserve also includes a basketball court, ping pong tables, kickabout space, shelters and seating. There is no limit for the amount of performers at this site.

# Bookings

After you have completed the a Busking Registration Form, Camden Council will review your application. Once your application has been approved, you will be notified that your Busker ID is ready to collect. Busker IDs must be collected prior to booking a site and must be displayed at all times during your performance.
