

- Fencing below gardens is in poor condition
- Gardens Committee still to decide on replacement options for Rosemary hedges.

- Paths need to be topped up and rerolled.
- Request advice from Council landscaping team as to appropriate plants for hedging and screening
- Request review of pathway adjacent to barn connecting CTF to CCG for repair

Chairperson's Report

Welcome,

Once again, thank you for your ongoing interest in the future of the Camden Town Farm and your attendance at this meeting.

In particular, thank you for your contribution to the August meeting. As you are aware, particularly if you were on a previous 355 committee, we are a reference group acting in an advisory capacity rather than a management role. However, it is encouraging that the ongoing projects of the 355 committee have been recognised and the use of the Action log has been maintained.

It is pleasing to see, in the last few weeks, the greening up of the farm and the transformation in the condition of paddocks and particularly the cattle. The return of the farmer markets and a wedding event are indicators of a return to some form of normality to the farm.

Further rain events are forecast yet the SAM, IOD, and La Nina models cannot seem to make up their mind as to the longevity, intensity or location of the next event.

The restoration of internal fences, removal of rubbish and management of the cattle would remain as a priority however it is important the reference group is clear in its vision for the continued maintenance and development of the CTF, particularly the walkway and its proposed extensions.

As noted last month, it may take a few months to restore some sense of normality to the CTF however I am confident the reference group can move forward in a positive spirit of cooperation with council to restore and improve the functioning of the farm into the future.
