# 1. CAMDEN CHRISTMAS FESTIVITIES UPDATE

#### CAMDEN CHRISTMAS CONCERT

Senior Events Officer provided an event overview:

- o 17,000 attendees
- o Two stages, amusements
- A mix of Christmas inspired performances by local groups. Activities including a silent disco, inclusive space organised by the Shine Shed, bauble decorating etc
- o Over 50 stallholders including food and products
- o Two event sponsors Wests Group Macarthur (Gold) & Highland Shutters (Silver)

Mr Hyett provided feedback regarding sound on Main Stage in John Street. You were unable to hear the sound past the roundabout. Suggestion to find a new supplier or request that the existing supplier ensures that sound is heard from a distance.

Mr Hyett provided additional feedback regarding entertainment lineup. Request that local dance groups are first on stage as they often bring crowds.

Cr Cagney advised more stallholders would have worked well in the space. Providing a suggestion of taking a bond from stallholders to secure stalls prior to the event.



#### **ORAN PARK CHRISTMAS CONCERT**

Senior Events Officer provided an event overview:

- o 2000 attendees
- Christmas performances by local groups including dance groups, choirs, schools. Santa and a helper, roving performers, face painting and the lighting of the Christmas tree
- 22 stallholders both food and product. Food was the most popular, in future product stalls will be reduced
- Two event sponsors Wests Group Macarthur (Silver) & Highland Shutters (Silver)

Ms Musgrave advised the AV supplier was mixing and sounding prior to the event. Can the supplier can be provided performer music prior to the event.

Ms Musgrave also advised roving elves were scheduled at the same time as Camden Music Festival. Suggestion if the roving performers be scheduled during breaks between stage performers.

Cr Cagney suggestion the date and time could have been better to suit attendees for higher attendance. E.g.; Friday at 4pm and the location could be rethought as at this stage there is no development on that side of Peter Brock Drive which reduces drive by traffic past the event.

# 2. AUSTRALIA DAY UPDATE

**COMMUNITY EVENT - PRE-PARADE ENTERTAINMENT** 



Senior Events Officer provided an event overview:

Pre-parade entertainment was organised from 9-10am along Argyle Street and in John Street. We had bouncing kangaroos as well as temporary Australiana tattoos and flag giveaways. The weather was extremely warm so there wasn't a huge turnout in attendance until approximately 9.45am but as the parade began the crowd made their way and it was a great turnout, approximately 2,500 attendees.

# **COMMUNITY EVENT - MACARTHUR LIONS STREET PARADE**

Mr Gilroy from Macarthur Lions Club provided an event overview.

Cr Cagney advised that the Mayor and Councillors encourage to push the parade earlier in the day due to the hot weather, e.g; 9am. She also suggested that more entertainment in the event area such as John Street.

Mr Gilroy raised concerns about moving the parade earlier if participants don't show up on time.

Mr Hyett asked if we could have a sausage sizzle for people attending the parade, Mr Gilroy advised the Macarthur Lions Club holds one at Onslow Oval after the parade.

Mr Gilroy stated that traffic management needs to be discussed for next year. Mr Gilroy also advised that there may be an option for a route change and site plan to be amended with the parade turning into John Street.

Senior Events Officer advised that Ted will need to provide notes and feedback to Council.

Ms Musgrave asked if an Events Reference Group member could be involved in the Australia Day debrief. Senior Events Officer advised no.

#### **CIVIC EVENT - CITIZENSHIP CEREMONY**

Senior Events Officer provided an event overview on behalf of the Civic Events Officer.

Camden had 60 new citizens received their citizenship from 22 different nationalities

# **CIVIC EVENT - AUSTRALIA DAY AWARDS (GC)**

Senior Events Officer provided an event overview on behalf of the Civic Events Officer.

Over 40 nominations for the Australia Day Awards across all five categories were received. It was a very positive atmosphere for all the nominees and winners.

Ms Musgrave asked why the lunch for winners post ceremony was not more of a cocktail reception in the larger room at the Civic Centre rather than a sit down lunch in the smaller



room. There was also a query from Ms Musgrave as to why there was no group photo taken with the winners and the Mayor. It was suggested that this be included in future.

- Events team and Macarthur Lions to investigate options for a route change and site plan to be amended and parade turns into John Street
- Events team to explore ways to move the parade earlier in the day
- Mr Gilroy to provide notes and feedback to Council regarding Macarthur Lions Parade

# 3. PAWS IN THE PARK UPDATE

# No recommendation due to informal meeting

Senior Events Officer provided event update:

Farmer Dave, Celebrity guest has been booked in for the events. Additional quotes were sought from celebrity vets including Dr Chris Brown (\$30k) & Dr Lisa Chimes who is a co-presenter on Bondi Vet (\$12,500)

Roving entertainment, an agility course by the Siberian Huskies, Face Painting, Caricature (owner and pet)

Council's website is updated. EOI's are now open calling for stallholders.

Cr Cagney provided positive feedback on the event advising she enjoys the Paws in the Park event as it is easy to access and great for the kids.

Ms Musgrave suggested promoting the event for people who don't have pets so it is inclusive of everyone.

#### **Action Items:**

- Events team to promote events targeted at the general public, stallholders and performers as well as pet related businesses or organisations.
