

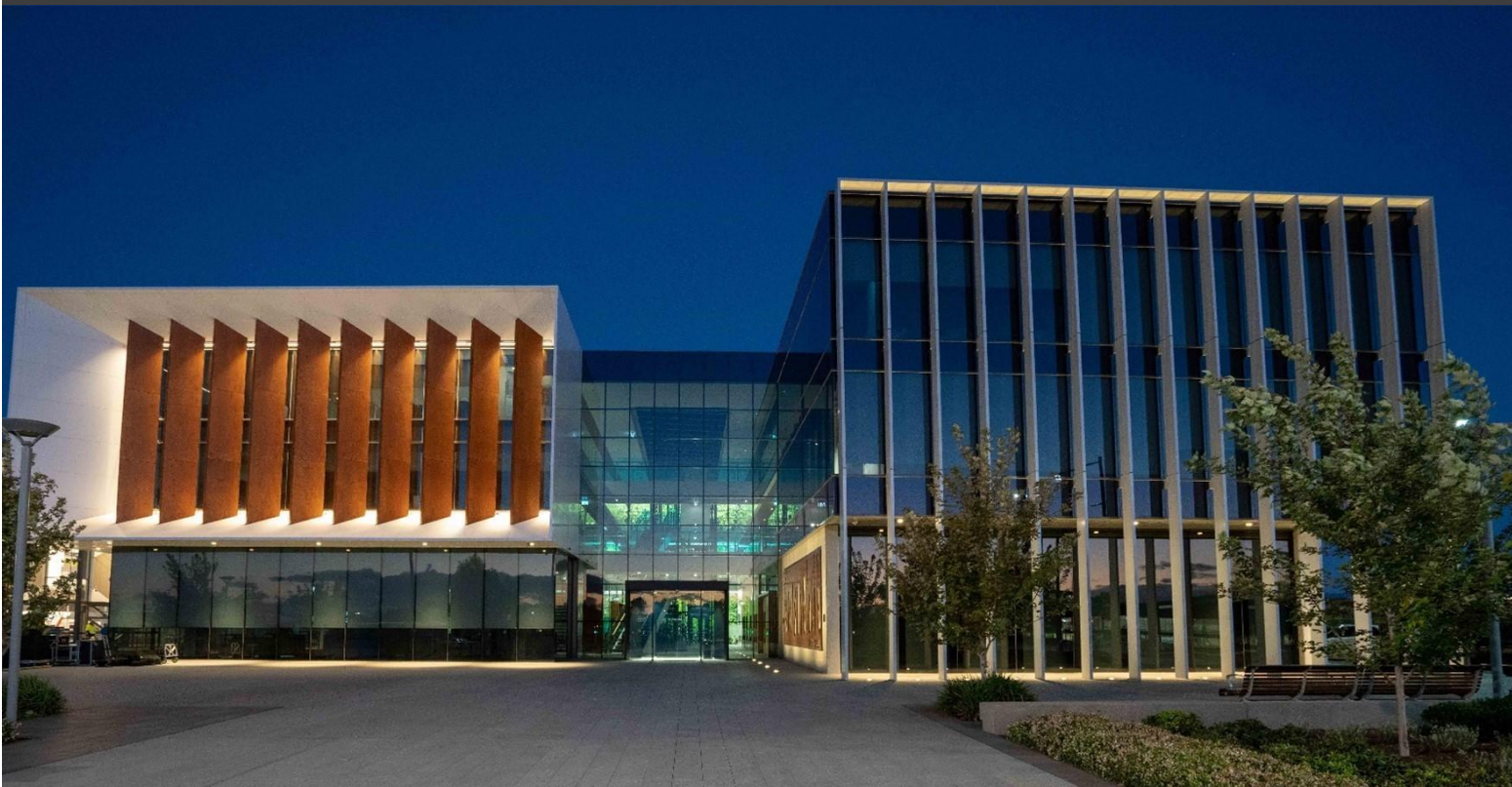

Group to decide which consultation questions to ask (approximately 2-3)

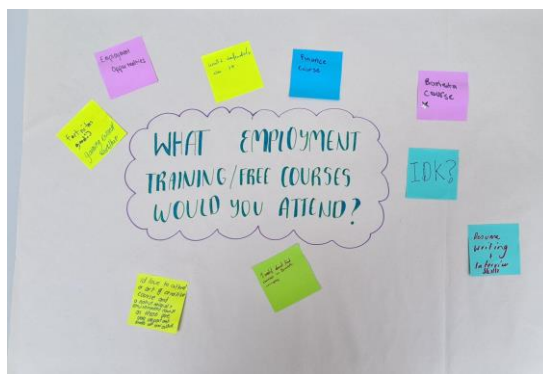
