



# AMENDMENT TO THE RURAL LANDS STRATEGY (RLS)

## FACT SHEET

### CAMDEN COUNCIL RURAL LANDS STRATEGY WAS ADOPTED 26 SEPTEMBER 2017

As the Camden LGA has grown, there has been increasing pressure to develop Camden's rural lands. To help respond to this pressure, a Rural Land Strategy (RLS) has been adopted by Council.

### AMENDMENTS ARE PROPOSED TO THE ADOPTED RURAL LANDS STRATEGY

The amendments proposed to the RLS are of a minor nature and include responding to the recent changes to State Government policy. The amendments do not change the principles or intent of the RLS, but the document needs to be changed to be current.

The amendments to the RLS include:

- Amendments to replace reference to the Draft South West District Plan with the adopted Western City District Plan;
- Updates to reflect the current information on the Outer Sydney Orbital (OSO) corridor.

### DOES THIS MEAN THAT COUNCIL HAS APPROVED THIS AMENDMENT?

No. The draft amended RLS is being placed on Public Exhibition. At the conclusion of the exhibition, Council officers will prepare a report to Council for consideration. All submissions will be considered as part of the report.
