#### <u>AMENDMENT</u>

- a) to be deleted; and

This landscaping screening shall consist of at least four native trees capable of reaching at least five metres to appropriately screen the farm building. Advanced species should be used at a height of minimum five metres as planted. The screening shall reflect an informal pattern as to integrate with the existing vegetation to be retained.
