



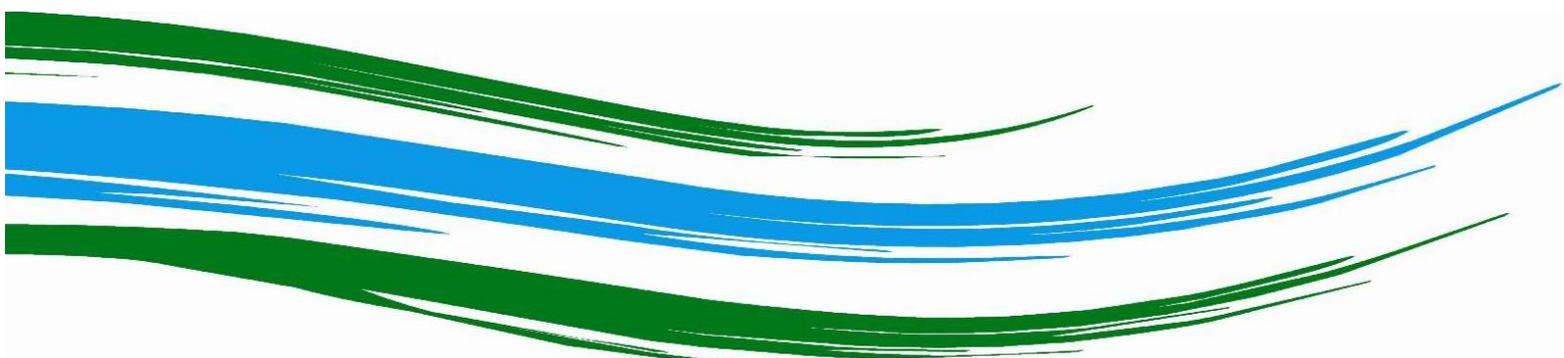

- ii. fund approximately \$13,000, required for the wrapping of the trucks, from within the 2019/20 budget.

Resolution: Moved Councillor Farrow, Seconded Councillor Symkowiak that Council:

- i. endorse the draft amendment to Camden Development Control Plan 2019 – Schedule 6 Camden Lakeside;
- ii. exhibit the draft amendment to Camden Development Control Plan 2019 – Schedule 6 Camden Lakeside in accordance with the provisions of the *Environmental Planning and Assessment Act 1979* and the *Environmental Planning and Assessment Regulation 2000*;

- iii. at the conclusion of the public exhibition period:
  - a. if there a no unresolved objections, grant delegation to the General manager to adopt the DCP amendment and publicly notify its adoption in accordance with the provisions of the *Environmental Planning and Assessment Act 1979* and the *Environmental Planning and Assessment Regulation 2000*; or
  - b. if unresolved submissions are received, receive a further report outlining the outcomes of the public exhibition for Council's consideration.

- i. formally enter into an alliance with the Western Parkland Councils in accordance with the draft Western Parkland Councils Deed of Agreement and Section 355 of the *Local Government Act 1993*, and authorise the Mayor to execute the draft Western Parkland Councils Deed of Agreement;
- ii. contribute \$20,000 for the 2019/2020 financial year from a future quarterly budget review, and allocate \$40,000 annually from Council's 2020/2021 budget to the Western Parklands Councils alliance; and
- iii. endorse the draft Western Sydney Health Alliance Memorandum of Understanding which will be executed under delegated authority.

- iii. write to The Hon. Victor Dominello MP, Minister for Customer Service thanking him for the funding; and
- iv. write to Mr Peter Sidgreaves MP, Member for Camden thanking him for his support.
- v. write to the Camden Tigers Soccer Club congratulating them on their efforts for the community.
